If the application is rejected, the \$15.00 processing fee WILL NOT BE REFUNDED. If a Card is issued to me, it will be accompanied by a cardholder agreement.

My retention and/or use of the Card will constitute my agreement to be bound by all of the terms and conditions set forth herein.

The Card is the property of Dollar and is non-transferable. The Card may be cancelled, invalidated, and/or the conditions of its use modified without notice to me. I will surrender it to Dollar upon request. Dollar reserves the right to repossess a Card with or without demand, and I hereby waive prior notice, a pre-seizure hearing and judicial process as a prior condition to Dollar's repossession of the Card.

Cash Deposit Identification Card may be used at Hertz, Dollar Rent A Car, Thrifty Car Rental and Firefly Rent A Car.

I understand that only I will be authorized to use the Card. I will be liable for all charges incurred by authorized use of the Card.
